



## Educational Support

### **Ensuring a strong base for quality learning**

In our efforts to improve the learning outcomes of deprived children, especially from marginal communities, Sanganeria Foundation for Health & Education (SFHE), proposes to offer **merit-cum-means scholarships** for eligible students to pursue their College education.

We support those students who are stuck at the bottlenecks and find no way to complete their studies, by offering monetary assistance to fulfil their mission; thereby helping them to achieve a befitting career.

Since the last two decades, SFHE has been involved in building-up a continuum of care through health and education. In consonance with its mission, SFHE now offers various ace scholarship programmes, which can be availed by needy students, who want to complete their education.

### **Eligibility:**

- The Candidates must be enrolled as whole-time students in a recognized Institution leading to a Government approved Diploma or Degree.
- Applicants must have scored at least 75% marks in the previous qualifying examination i.e., Class 12 or graduation.
- Annual family income of the applicants must be less than INR 6,00,000 from all sources.

**The applicants are required to maintain an average of 65% marks in previous semesters to ensure the renewal of the scholarship for subsequent years of studies.**

The number of selected candidates may vary from year to year. The Financial assistance will be provided to the selected candidates on the following basis:

### **Undergraduate/Post Graduate (General Education) students:**

- (i) **Day Scholars** : Amount equal to Full annual Fee charged by the institution Plus Rs.15,000 per annum, subject to a maximum of Rs.1,20,000/- per annum all inclusive.
- (ii) **Residents: Those living in the Hostels of the College/University.** (No Paying Guests). Amount equal to full annual Fee charged by the

institution + Hostel Fees + INR 15,000 per annum subject to a maximum of Rs. 2,40,000/- per annum all inclusive.

**Undergraduate/Post Graduate (Technical/Professional Education) students:**

- (iii) **Day Scholars:** Amount equal to Full annual Fee charged by the institution Plus Rs.20,000 per annum, subject to a maximum of Rs.1,50,000/- per annum all inclusive.
- (iv) **Residents: Those living in the Hostels of the College/University** (No Paying Guests). Amount equal to full annual Fee charged by the institution + Hostel Fees + INR 20,000 per annum subject to a maximum of Rs. 2,50,000/- per annum all inclusive.

**General Conditions:**

1. Those students who wish to avail the financial Assistance from SFHE, should submit their applications 'Online' latest by 15<sup>th</sup> August each year. All applications received will be reviewed by an expert committee of Academicians who will recommend the eligible candidates to SFHE for approval. The SFHE will be the Final Authority for taking a decision and its decision in all matters will be final and binding and will not be questioned and challenged. The candidates who are finally approved will be intimated by 30<sup>th</sup> September each year.
2. All applications must contain the following information:
  - a) Name and address of the student along with contact details.
  - b) Name and address of the College with name of the Head of the Institution.
  - c) Examination passed, with marks sheets, of all examination from High School onwards.
  - d) The Course in which studying and the duration of the Course.
  - e) Day Scholar/Resident - Certificate from Institution to be attached.
  - f) Family details, in brief, mentioning the family income of the Father and Mother combined and the number of the dependents, with ages and relation on the Parents/Guardian. If employed salary certificates and self-employed, then Tax returns.
  - g) Participation in other activities like sports/dramas/debates and other cultural activities
  - h) An essay about the Ambition in life by the candidate.
  - i) Category: General/OBC/SC/ST
3. **All applications must be duly forwarded and recommended by the Head of the Institution. The recommendation must also clearly mention whether the**

**candidate is in receipt of any other scholarship or financial assistance from any Government/University/Board/College or any other private Body.**

4. All recipients will be subject to the Rules of Discipline of the Institution and the Financial Assistance can be stopped if the student is found guilty by the College for violation of discipline.
5. Normally, the assistance once granted will continue for the duration of the course subject to the condition that the candidate will maintain a good academic record and discipline. However, he/she will have to apply every year for renewal by the 15<sup>th</sup> August.
6. The financial assistance will be disbursed through the Institution and the decision of SFHE shall be final and binding in all matters.
